AN ORDINANCE AMENDING CHAPTER 180 OF THE CODE OF THE CITY OF HARRINGTON RELATING TO MUNICIPAL FEES FOR LICENSES AND TRASH COLLECTION

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF HARRINGTON IN COUNCIL MET:



This Ordinance amends the Municipal Fees for the City of Harrington to condense the category names for business licenses, remove the fee for a change of business location, add a fee for a peddler/solicitor license, correct typographical errors, reduce the quarterly fee for trash collection from \$51.76 to \$51.70, and add a note about sewer impact fees.
