ORDINANCE 23-03

AN ORDINANCE AMENDING CHAPTER 180 OF THE CODE OF THE CITY OF HARRINGTON RELATING TO VARIOUS MUNIICPAL FEES AND CLASSIFICATIONS.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF HARRINGTON IN COUNCIL MET:

Section 1. That § 180-1 A shall be amended as follows:

§ 180-1 Fees established.

The fees charged by the City of Harrington for the various municipal services provided by the City of Harrington shall be as stated in the tables attached hereto and incorporated herein by this reference.
